- a. "Authorized Organization" means an organization (an RHA, a First Nation or other organization) with whom Manitoba has entered into an agreement in order to facilitate access to PHIMS,
- b. "Authorized User" means an employee, agent or contractor of an Authorized Organization (the employer) permitted access to PHIMS,
- c. "Service Delivery Location (SDL)" means a public health office or a Community Health Centre,
- d. "User Role" means the specific role or roles to which an Authorized User is assigned and which prescribes what Information the Authorized User is permitted to access, use and disclose.

1. Background

1.1. Data Access Scope for Investigations in PHIMS

Access to individual client case investigations within the investigation module in PHIMS is based on permissions for specific encounter groups (Sexually Transmitted and Bloodborne Infections, Communicable Diseases, and Tuberculosis).

In Manitoba, Authorized Users ("users") of the investigations module have access to all investigations in encounter groups assigned to the logged in user for all PHIMS clients. This was decided as a result of a number of considerations, including:

- Clients can receive services at service delivery locations other than their default public health office, either within or outside their home health region;
- Cases and outbreaks of vaccine preventable diseases also cross regional boundaries and may involve multiple public health provider organizations;
- It is important to be aware of all concurrent or previous investigations for a client within an encounter group, regardless of which organization is responsible for the investigation.

However, for some reports with access to line-level client data, users may only run reports for investigations associated with their organization.

1.2. Privacy/Data Sensitivity

This report is set at the Manitoba level. This means users who have access to this report can "view" data for all regions. This report security is also based on the encounter group access of the logged in user. This means this report will only display investigation information for diseases included in the encounter groups.

The report includes data at the level of the individual and contains personal health information.

1.3. Permitted Disclosures

No disclosure permitted

Note re: Permitted Disclosures - In general, Standard Reports in PHIMS have been designed for internal use for day-to-day public health and health service delivery and limited to Authorized Users of Authorized Organizations. Authorized Users may only disclose information from the report that relates to their Designated Health Region. For First Nation Authorized Organizations, sites that have entered into a Bridging Service ISA, an Authorized User (of the Bridging Organization) generating the reports may provide Standard Reports to an FN Authorized User.

1.4. Data Stewardship

Users who have access to this report should have some background in report generation and basic epidemiology, and are responsible for the following:

Users may only run this report for their designated Health Region;

- The data is intended to be used by public health providers for case and contact management only. No disclosure of information to non-PHIMS users or non-Public Health providers is permitted;
- Users ensure data is managed securely and appropriately according to organizational guidelines.

Users who have access to this report will be subject to PHIMS audits documenting which user generated the report and on what date.

2. Purpose

The purpose of the Unknown Contact Summary Report is to give regional users the ability to print the details of an unidentified contact, in order to refer and send the details to another region or practitioner. The receiving region or practitioner would not have access to PHIMS. The Unknown Contact Summary Report would provide key details about the investigation to date without disclosing information regarding the source case.

2.1. Populations Included in the Report

The **Unknown Contact Summary Report** provides a summary of known information for the contact as well as transmission event details based on the source case interview. The report will return results of investigations for all contacts, regardless of their region of residence.

2.2. Recommended Uses for this Report

This report will be used by:

- Manitoba Health, Seniors and Active Living:
 - o To refer unknown contacts to out of province health authorities.
- Regional Health Authorities:
 - o To refer unknown contacts to region of residence for follow-up.

3. Selecting the Report Parameters

You can generate this report from the "Standard Reports" section in PHIMS.

This is a statistical report under Case: Manitoba Reports

- Click Reports & Analysis Reports (LHN) or the Reports tile on the dashboard
- Open the "Case Report Folder" by clicking on Show Report Folders
- Select MB23400B-Unknown Contact Summary <u>hyperlink</u>
- Enter the Transmission Event ID
- Click Generate Report Now

4. Report Output

The report will include identifiers entered in the Unknown/Anonymous Contact section within the selected Transmission Event (TE). These fields include:

- Name/Description (required, free text field)
- Contact Info (free text field)
- Contact Details (free text field)
- Disposition (required, droplets value)
- Disposition Details (free text field)

Information from the source case transmission event will include the TE ID, exposure start and end, all recorded mode(s) and nature(s) of transmission, exposure setting information (type, subtype, name, address), source case disease, classification, causative agent, further differentiation, current stage and any noted disease sites

If more than one unknown contact is recorded, the report will generate a record for each contact. The report is structured such that a new page will begin with each recorded unknown contact. Each recorded unknown contact will generate a two page report to ensure that back-to-back printing is accounted for. The user can determine if they wish to print one or two pages.
